## Retired Military Officers Files Friend of Court Brief to help former Trump National Security Adviser Gen. Michael Flynn

Lt. Colonel Dennis Gillem, Military Advisory Board Chairman of Uniformed Services League, urges Presiding Judge to grant motion to dismiss all charges

(Sun. 6/7/20) The Uniformed Services League and its Retired Military Officers Advisory Board this week filed an Amicus Curiae Legal Brief on Wed., June 3 (a week before the June 10 deadline) before Judge Emmet G. Sullivan "in support of the Defendant former National Security Advisor Lt. General Michael T. Flynn in furtherance of the Government's Motion to Dismiss the Criminal Information Against the Defendant (Docket No. 198)... This Brief argues that the Government's Motion should be GRANTED, and... that Flynn is not in contempt and has not committed perjury." (from the brief).

The brief was filed on Wed., 6/3 (before the 6/10 deadline) by Lead Counsel Todd Mosser of Philadelphia on behalf of the Amicus Curiae, Uniformed Services League and its chief adviser and spokesman, Lt. Col. Dennis Gillem, Chairman of the USL Retired Military Officers Advisory Board, which over the past 30 years has had over 100 flag rank officers in its ranks, including the late Thomas Moorer, USN (Ret.), its past Honorary Chairman and Chairman of the Joint Chiefs of Staff, and the late Major Gen. Richard Anson, USA (Ret.), its Chairman. Local Counsel on the brief is attorney Jon Moseley of northern Virginia. Attorney David Carroll of Ohio is "Of Counsel" advising during the legal brief preparation.

Colonel Gillem of Detroit, MI, hosts the largest syndicated talk radio show in America aimed at prodefense listeners, aired on 165 stations nationwide every weekend for 2 hours and reaching 100,000 listeners. Amicus Curiae Uniformed Services League has been a sponsor of some 20-minute segments of the show.

Gillem, Mosser and Moseley are available for TV, radio or newspaper interviews on this subject.

Lt. Col. Dennis Gillem, Uniformed Services League chief military adviser, said "It is now clear our own government targeted both President Trump and his then National Security Adviser designate for illegal surveillance, illegal leaking of information to the *Washington Post*, subjected the President to years of unwarranted investigations, and subjected Michael Flynn to unwarranted criminal prosecution. This is no way to treat an American hero like Michael Flynn, who served our country in combat and was once again serving his country when he was subjected to criminal conspiracy by outgoing leaders of our own government, the Department of Justice and the FBI. We are thankful to the Department of Justice under the leadership of Attorney General William Barr for revealing the truth and for their motion to dismiss the unfair prosecution of Michael Flynn. We are proud to file this *Amicus Curiae* supporting their motion."

Uniformed Services League and its Retired Military Officers Advisory Board, has supported servicemen unfairly accused of crimes in the past, such as Sgt. Derrick Miller, the Biden 4 group of four combat veterans jailed for returning fire in the defense of a U.S. diplomat in Iraq, First Sgt. John Hatley, Navy SEAL Chief Dave Swarts, Lt. Clint Lorance, Major Matt Golsteyn, Navy SEAL Chief Edward Gallagher, Navy Sailor Kristian Saucier and Lt. Michael Behenna. The latter 5 received a Presidential Pardon in 2019. Support for these men was given via nationwide petition campaigns, newsletters, booklets reaching 1 million or more Americans, Symposia on Capitol Hill at the House of Representatives, three premium placement (page 3 or back page) full page ads in *The Washington Times* supporting a Presidential Pardon, and meetings to support these cause with Congressmen and staff. Recently, USL through its associated foundation, Freedom Center Foundation, USL will provide \$5,000 directly to help General Flynn pay his legal defense expenses.
